'We need you' GM CEO Barra to young girls

In an article for the Detroit Free Press, GM's CEO Mary Barra remembers her childhood years and when she began her love for engineering and cars. "My dad worked for GM for 39 years. He taught me the love of engineering and cars and my mom said, 'Mary, you can do anything and be anything. You'll have to work hard, but you can be anything you want to be," Barra said. "I liked math and science in school and so engineering seemed like a natural pathway for me when I started college."

Fast forward, taking the charge as the first female CEO of an automaker, Mary Barra encourages young girls to think STEM and become leaders in the male-dominated career path. And to help, GM has partnered with the Girl Scouts, to create STEM programming for the young girls. DFP states that "GM gave the Girl Scouts a \$1 million grant to help the organization develop STEM programming for the scouts, which includes some supplemental STEM courses that any girl, not just Girl Scouts, can take. GM also helped develop the curriculum for automotive badges the Girl Scouts can earn."

GM Reports Third-Quarter U.S. Sales



General Motors (NYSE: GM) announced on Thursday, October 1, 2020, that it delivered 665,192 vehicles in the third quarter of 2020, a decrease in total vehicle sales of about 10 percent compared to a year ago. In a sign of a recovering industry, sales improved sequentially each month within the quarter. Industry and GM sales rebounded significantly in September, finishing the month with year-over-year sales increases. Total industry SAAR1 was an estimated 15.9 million vehicles for the guarter, up about 4 million units from the previous guarter.

"Our dealers are doing exceptionally well utilizing a combination of customer-facing online technologies – such as Shop. Click. Drive. – and showroom sales to deliver vehicles safely to our customers. This is contributing to retail share gains while we continue to refill the pipeline," said Kurt McNeil, GM vice president, U.S. Sales Operations. "Industry-wide, dealers are selling a high mix of large pickups as the summer comes to an end. Our strong large pickup and all-new full-size SUV lineups from Chevrolet and GMC are selling extremely fast."

WRN dealers delivered 39,641 retail units in Q2 which represents a 16.9% decrease compared to Q2 2019, outpacing GM and the industry.
